- Total Accounts Receivable: \$2,032.71. Total delinquencies over 90 days: \$650.00
- Statements are mailed monthly and were last mailed on July 6th. Four accounts currently have a balance.
- No accounts are with Ansbacher Law at this time.
- Reminder: A new step in the collection procedure per the State Legislature went into effect on July 1, 2021. A Notice of Late Assessment (NLA) letter and ledger must be sent thirty (30) days prior to a NOIL being sent. In addition, a lien cannot be filed until forty-five (45) days after the NOIL is sent (used to be 30 days.
- There has been one new owner since the April 21, 2022 meeting (413).
- The trash situation at the dumpsters seems to be under control. The rotten beams have been replaced.
- Quick Catch was hired to handle a raccoon issue on the property. A total of fourteen (14) raccoons
 were caught and removed. A repellent is applied monthly. Two homeowners have reported
 seeing raccoons at the dumpster recently. Traps have been set.
- All maintenance issues should be reported to Management.
